1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). Other matters not affecting our opinion which we draw to the attention of the authority:

The AGAR was not accurately completed before submission for review:

• Question 11a, 11b in the Accounting Statements and Assertion 9 in the Annual Governance Statement were left blank when originally submitted. The AGAR was returned for amendment and 11a and 11b have been correctly answered No and N/a, Assertion 9 has been correctly answered N/a.

The council have provided minutes resolving to re-appoint the internal auditor, but the minutes do not indicate whether the independence of the internal auditor has been considered, which is not in line with best practice contained in the practitioners' guide.

The Council did not provide a letter of engagement for the services of the Internal Auditor. Best practice recommends that an engagement letter is in place to set out inter alia the scope of the audit as agreed with the council. It is also best practice to consider the independence of the internal auditor each year on reappointment and we recommend that this is minuted.
