All items on the Clerks report were noted.

- ❖ A response has been received from Marc Cashmore, SGC, regarding the issue of a single bollard not being sufficient at the end of the walk to school path, Beckspool Road, Frenchay. He has offered to meet and discuss. Email sent to Frenchay members and Cllr Eldridge who raise the issue.
- ❖ A response has been received from Dan Taylor, SGC, regarding the issue of flooding within the parish that was raised by a member of the public at the previous Council meeting. The member of public has been contacted with an update and the Clerk has asked for an update on any remedial works that are planned for Mill Road viaduct, and Bristol Road, Hambrook (outside the White Horse) as these are two of the main areas of flooding within the parish.
- Our insurance broker is working with our insurance company to try and get them to accept that the remedial works to the roof are not an immediate concern and that we should still be covered if we do not do the work.
- ❖ A meeting was held with representatives from Winterbourne Football and Cricket Clubs. All attendees are happy that revised planning is being submitted and are fully onboard with the project. A further meeting has been arranged, with the architect in attendance, to start looking at interior requirements.
- Chosen contractors for the remedial tree works have been contacted. Some trees have TPO's and so a planning application will need to be raised.
- Winterbourne Tennis Club have been advised they can site their storage container.
- ❖ Frenchay Flower Show committee have been advised they can use Frenchay Parklands for the 2025 Flower Show
- ❖ Highways were contacted regarding mud on Bristol Road. SGC Liz Brennan advised that SGC Officers are now aware and the enforcement team are working to resolve the issue.
- ❖ Kim has completed her ILCA (Introduction to Local Council Administration) training.
