# 52.08/25 Planning Applications

#### Winterbourne

- a) P25/01529/F Land at Rose Cottage, Church Lane (Erection of 1no self build dwelling with associated works (resubmission of P24/02078/F) Resolved, The Parish Council did raise an objection. The Parish Council feel this is an inappropriate development.
- b) **P25/01709/TCA Old Manse, Bristol Road, Hambrook** (Works to crown reduce 1 no. Apple tree (T1) to leave a finished height of 4.5 m and radial spread of 4 m, 1 no. Apple tree (T2) to leave a finished height of 4.5 m and radial spread of 4 m, 1 no. Crab Apple tree (T3) to leave a finished height of 4.5 m and radial spread of 4 m, and 1 no. Holly (T4) to leave a finished height of 4.5 m and radial spread of 3 m. Trees situated in the Hambrook Conservation Area). **Resolved,** The Parish Council did not raise an objection.
- c) **P25/01690/CLP 7 Swan Lane** (Change of use of dwelling (Class C3) to a children's home for a maximum of 3 no. children, with up to 3 no. carers, two of whom will sleep overnight, working on a rota basis (Class C2). **Resolved,** The

- Parish Council did not raise an objection. However, the Parish Council do have concerns there is inadequate parking.
- d) P25/01790/CLP Bay Tree Cottage, Bristol Road, Hambrook (Installation of Air Source Heat Pump and associated new 2m boundary fence and 2m gate). Resolved. The Parish Council did not raise an objection.
- e) P25/01802/TRE Waters Edge, 2 Burghley Court (Works to reduce back to previous points 1.no Sycamore Tree to leave a finished height of approx 15m and a radial spread of 7m. Covered by Tree Preservation Order SGTPO 02/96 dated 9th April 1997). Resolved, The Parish Council did not raise an objection.
- f) **P25/01621/HH 2 Matford Close** (Erection of single storey side and rear extension to provide additional living accommodation) **Resolved**, The Parish Council did not raise an objection. The Parish Council feel this would be an improvement.
- g) P24/00989/O Land Adjacent to Bridge Bungalow, Old Gloucester Road, Hambrook (Demolition of existing buildings and erection of 2no. student accommodation buildings (Sui Generis) (88no. studios in total) with associated parking, cycle and bin storage (Outline) with access, landscaping, layout and scale to be determined, all other matters reserved) Resolved, The Parish Council did raise an objection. The Parish Council still hold the same comment as the location has not changed and feel that it this is too close to the M4 with no local accessible facilities. The Parish Council have concerns with inadequate parking on this overdeveloped site. As with all new builds the Parish Council would encourage developers to consider sustainability, biodiversity and the environmental impact and stress the importance of designing a sustainable building. There is no actual commitment to any environmental factures.

- h) **P25/01612/TRE Woodstock, Quarry Road** (Works to crown lift a group of various trees and vegetation overhanging wall (G1) to 5m over Pearces Hill. Works to fell 1no. Ash tree and coppice 1no. Holly tree (G2) to beneath split in union, covered by Tree Preservation Order SGTPO 15/12 dated 15th December 2012). **Resolved,** The Parish Council did not raise an objection.
- i) P25/01675/HH Taormina, Bristol Road (Demolition of existing garage. Erection of two storey side and rear extension to form additional living accommodation. Erection of detached garage with gym/games room. Erection of front porch) Resolved, The Parish Council did not raise an objection.
- j) **P25/01757/TCA Lodge Cottage, Beckspool Road** (Works to 1no Cherry Tree to remove 2no overhanging branches within Frenchay Conservation Area) **Resolved,** The Parish Council did not raise an objection.
