Winterbourne

- a) **P26/00397/HH - 168 Watleys End Road Winterbourne** (Erection of single storey rear extension to form additional living accommodation). **Resolved, The Parish Council did not raise an objection.**
- b) **P26/00406/F - Victoria Cottage 15A Bury Hill Winterbourne Down** (Demolition of existing barn and erection of a detached outbuilding to form a short term holiday rental property). **Resolved, The Parish Council did not raise an objection.**

P25/02769/PIP - Land At Cloisters Road Winterbourne (Permission in principle for the erection of a minimum of 1no. and up to a maximum of 1no. dwellings.) REFUSAL. The Parish Council did raise an objection.

P25/02940/F - Hammond Court Farm Trench Lane Winterbourne (Demolition of fire damaged dwelling. Erection of 1no. replacement dwelling with associated works). REFUSAL. The Parish Council did not raise an objection.

P26/00252/TRE - 23 Prospect Close Winterbourne Down (Works to crown reduce 1.no Sycamore Trees (T1) by 2 metres, lateral spread by 4 metres, crown clean and reduce overhanging branches by 5 metres to provide clearance. Works to 1.no Sycamore Tree (T2) to reduce height to 16 metres, crown reduce by 2 metres, crown clean and reduce overhanging branches by 5 metres to provide clearance. Covered by Tree Preservation Order 23 dated 31st December 1973). REFUSAL. The Parish Council did not raise an objection.

P25/02853/F - Verge At Stoke Gifford Bypass Opposite Curtis Lane Hambrook (Erection of a micro energy storage system (Battery Box) with installation of timber fencing and associated works). APPROVE WITH CONDITIONS. The Parish Council did not raise an objection.

P26/00113/HH - 30 Park Avenue Winterbourne (Erection of single storey rear extension to form additional living accommodation). APPROVE WITH CONDITIONS. The Parish Council did not raise an objection.
