- a) **P26/00580/HH - 61 Station Road Winterbourne Down** (Erection of a two storey side and single storey rear extension to form additional living accommodation).  
**Resolved, The Parish Council did not raise an objection.**
- b) **P26/00617/HH - 117 Watleys End Road Winterbourne** (Installation of 2no. front dormers to form additional living accommodation). **Resolved, The Parish Council did not raise an objection.**
- c) **P26/00619/HH - Lockstone Leaze The Stream Hambrook** (Conversion of existing detached garage to form additional living accommodation ancillary to the main dwelling). **Resolved, The Parish Council did not raise an objection. The Parish Council would like a condition that the application will remain an ancillary dwelling.**
- d) **P26/00693/TRE - Crossley House 109 High Street Winterbourne** (Works to crown reduce 2.no Oak Trees by 2m to leave a finished height of 13m and a radial spread of 13m. Works to 1.no Robina Tree to crown reduce by 2m leaving a finished height of 10m and radial spread of 8m. Covered by Tree Preservation Order SGTPO 03/94 Dated 22nd October 1996). **Resolved, The Parish Council did not raise an objection. The Parish Council would like consideration for appropriate timing for works due to the nesting season.**

- e) **P26/00702/HH - 90 Old Gloucester Road Hambrook** (Erection of single storey side/ rear extension to form additional living accommodation). **Resolved, The Parish Council did not raise an objection.**
- f) **P26/00743/PNH - 22 Bradley Avenue Winterbourne** (The erection of a single storey rear extension, which would extend beyond the rear wall of the original house by 3.22m, for which the maximum height would be 3.60m, and for which the height of the eaves would be 2.40m). **Resolved, The Parish Council did not raise an objection.**

The Parish Council would also like consideration for appropriate timing of works due to the nesting season.**

Box Elder Tree (T2) to 4 metres and reduce height of all border Laurels (T3) to 3 metres. Works to fell 1no. Cypress Tree (T4) and 1no. Sycamore Tree (T5). All trees situated within Frenchay Conservation Area). **Resolved, The Parish Council did not raise an objection.
